Recycled Content	Product must be 100% recovered material, agricultural residue or combination of both
Post-Consumer Material	40% of recovered material must be post-consumer

### Low-Impact Manufacturing



Fresh Water Use	Limits on total water used during the papermaking process: no more than 19,250 gallons / ton of final product	
Total Energy Use	Limits on total energy used during the papermaking process: no more than 17.0 millions BTUs / ton of final product	
Freedom of Association and Collective Bargaining	Workers shall have the right to participate in unions and collective bargaining	
Freedom of Labor	Manufacturer cannot use forced, bonded, or child labor	
Freedom of Discrimination	Manufacturer cannot discriminate against employees and cannot tolerate harassment, intimidation, or exploitation	
Occupational Health and Safety	Manufacturer must provide a safe and hygienic workplace and health and safety training to minimize workplace hazards, accidents, and injury	
Conditions of Employment	Manufacturer must offer fair conditions on wage, working hours, and overtime

Primary & Secondary Packaging - Paper	Must be recyclable, and made from 100% recovered materials
Primary & Secondary Packaging - Containerboard	Must be recyclable, and made from 30% recovered materials
Primary & Secondary Packaging - Plastic	Must be recyclable, source-reduced, contain 25% recovered material, or have an effective take-back program
Resin Identification Code	Plastic packages must be marked with the appropriate Resin Identification Code
Packaging Chemicals	Phthalates, Bisphenol A, Chlorinated Materials, Hexavalent Chromium, Lead, Mercury, and Cadmium must not be intentionally added to primary packaging.

#### Verified Performance and Claims



Product Performance	Products must demonstrate an effective level of performance as measured by TAPPI or ISO standards for basis weight, tensile strength, and stretch and water absorbency. Products must meet specified cut-off levels
Marketing Claims	Green Seal trademarks cannot be used in conjunction with any claims that might mislead consumers as to the extent or nature of certification
Labeling	Must include instructions for proper disposal to minimize waste.
